Suzie also said she would check with Tina Cannon, District 10 Policy Aide, regarding our desire to realign school boundaries.

4. FINANCIAL REPORT

- a. February 2016 financial statements: Everything looks good and net income is ahead of budget by over \$4000. A few minor corrections will be made. Reviewed and approved with those corrections.
- b. Review delinquent accounts in accordance with the Collection Policy: Reviewed and determined that there were no accounts which warranted initiation of collection action. Current outstanding receivables balance is \$1598, a bit high but not unusual for the beginning of the year.
- c. Our CPA has submitted an extension for our tax return.

Jesse will get estimates for repairing the uneven portion of the walkway to the clubhouse.

6. OLD BUSINESS

- a. Update on the implementation of the Bufkin Engineering infrastructure plan for Association owned properties. The wall repairs have been completed and paid for.

- c. Update on Westslope Cove roadwork repair. Bryan met with JD. The patches have been fixed and final payment to JD has been released. The only remaining question is whether the cracks between the patches and existing road should be filled.
- d. Update on new drainage fees and survey of water taps. Still a question as to what COA considers impervious cover. Are our private roads included? Suzie Chase said she would check. Jesse has arranged to have three water taps and meters deactivated. This will save the HOA about \$120/month.
- e. Update on wall responsibility at 4718 Twin Valley Drive. Bryan Harter was going to check with our lawyer so we could have a survey done to determine wall location. Will get update next meeting.
- f. Update on options to reduce electric demand charge. No update yet.
