1. CALL TO ORDER: 7:00 p.m. Present at the meeting:

**2. APPROVAL OF 2021 MINUTES OF THE ANNUAL MEETING:** The minutes of the February 17, 2021 minutes were approved without corrections.

## 3. **COMMITTEE REPORTS**:

- a. Communications Committee: Chair, Lisa Harding, reported that we currently have 67 homeowners on our Facebook page. She is working on ways to increase the number of people on our private page.
  - b. Environmental Committee: Chair, Angela Clark, submitted a report showing 50 reviewed proposals. The report also outlined the scope of work, listed the members of the committee, the process involved and meeting dates. - c. Reserve Committee: Chair, Bill Russo, reported that the reserve funds of \$210,469.55 are considered adequate to meet the needs for 2022.
- d. Social/Activities Committee: Chair, Jeff Howdeshell reported that no social events were held in 2021 due to Covid.
- e. Welcome Committee: 21 new neighbors moved into CMHOA. Currently we do not have a chair for this committee.
- 4. PRESIDENTS REPORT: Jason Fischer discussed significant actions taken by the Board.
  - a. Brush clean up in common areas continue to be a big task and budget item for our HOA.
  - b. The Board is exploring the possibility of a sport court/pickle ball court. The first step Is to determine the impervious cover ratio of our neighborhood.
  - c. Jason reported that fire mitigation/maintenance of common area is on a rotating schedule and to email Jesse with fire mitigation questions.

**5. FINANCIAL REPORT:** Interim Treasurer Bill Russo presented the financial report. We are tracking very close to budget and our income is adequate. A major expense is the brush clean up and clearing.

Bill presented the 2022 budget.
